On June 8, 2018 in San Diego, the San Diego Electrical and Sound Technician Apprenticeship Graduation and Awards ceremony was held at the Hilton San Diego Bayfront.

Over 750 guests gathered this year to celebrate & honor the Training Center's 96 graduates, who received their Journeyman credentials. ## WHY NOT TO USE OUT-OF NETWORK PROVIDERS FOR CHEMICAL DEPENDENCY/SUBSTANCE ABUSE TREATMENT

Under the PPO Plan’s exclusive agreement with Optum for providing treatment for chemical dependency/substance abuse conditions there is a set network of physicians and facilities that **must** be utilized by covered participants in order to receive the highest benefit payments. In-network provider charges are basically paid at 80% of a discounted amount after their calendar year deductible has been satisfied with the participant owing their 20% balance up to the negotiated maximum allowable charge. The balance of billed charges must be written-off by the provider.

When a participant uses an out-of-network provider the Plan will make payment on those charges at only 60% of what

the maximum allowance would have been if an in-network provider had been utilized. Further, in the absence of any contractual discount arrangement the service provider may seek payment from the participant of the entire balance of their billed charges, whatever that may be. This often becomes a very large amount and it is common for the provider to turn unpaid balances over to a collection agent who only gets paid if they are successful in collecting the amount owed.

The following are actual examples of the difference in pricing, claim payments and patient responsibility between in-network (“INN”) and out-of-network (“OON”) facilities for comparable type, quantity and duration of treatment:

Submitted Amount	\$6,498.83	\$22,200.00
Allowed Amount	\$3,666.00	\$15,318.00
Paid Amount	\$3,189.93	\$8,290.80
Member Responsibility	\$476.07	\$6,127.20

Day Treatment	INN	OON
Submitted Amount	\$9,835.20	\$19,200.00
Allowed Amount	\$2,820.00	\$12,096.00
Paid Amount	\$2,820.00	\$7,257.60
Member Responsibility	\$0.00	\$4,383.40

Structured Out-Patient	INN	OON
Submitted Amount	\$9,650.76	\$15,000.00
Allowed Amount	\$1,692.00	\$12,450.00
Paid Amount	\$1,692.00	\$7,470.00
Member Responsibility	\$0.00	\$4,980.00

As you can see there is a substantial difference between billed charges for comparable services. Not only are there no discounts by out-of-network providers, but those facilities are free to run up very large charges for diagnostic and laboratory services that would not be covered if performed by a network provider. **These charges and the balance of facility charges will expectedly be the responsibility of the participant.**

When in need of mental health or chemical dependency/substance abuse services please be sure to use only Optum network service providers in order to avoid any large outstanding balances and possible collection issues. ## WHEN TO USE NEW HINES & ASSOCIATES ADVOCACY SERVICES

Hines & Associates now provides "FREE" advocacy services to PPO Plan participants. Through this advocacy services program it will be possible to contact registered nurses, experienced health care navigators, certified health care coaches and others for assistance with medical questions, benefit and coverage issues or questions, service provider selection procedures or referrals, claims and/or provider billing questions, referrals to Plan provided services and/or cost-containment programs, questions about pharmacy and Mental Health/Substance Abuse coverages and service providers, and assistance in using or navigating the Trust website. To begin this process eligible PPO Plan participants may call 1-888-893-6756 and a Hines nurse will initiate the intake process. Please note that the participant must be covered at the time services are rendered.

## PROVIDING THE TRUST OFFICE WITH CURRENT MAILING ADDRESSES IS IMPORTANT

For all participants the importance of keeping the Trust Office up to date with a current mailing address is to permit all communications issued by the Trust Office that have to do with announcements that may impact eligibility, benefits and/or claim payments or coverage issues to be delivered. If it appears a current mailing address is not available due to a piece of mail being returned to the Trust Office, after attempting to get an updated address from Local 569 the name of the participant may not be included in the monthly eligibility files sent to Plan A service providers (such as Optum and pharmacy) meaning their eligibility status will not be active at the time, thus a participant or an eligible dependent may

not be able to receive services or pick-up a prescription until this information is provided to the Trust Office and their record updated.

**For retirees, the impact of the Trust Office receiving a piece of returned mail will be the possible suspension of their monthly benefit payment until such time as a new address can be verified.** Therefore, all participants are urged to be sure any change of address is reported to the Trust Office as soon as possible in order to avoid a delay in being able to utilize plan benefits or an interruption of monthly pension benefits. Address change notifications are to be made in writing and can be delivered by mail, email, fax or in person. Please contact the Trust Office (x-310) with any questions in this regard.

## WHEN TO USE PPO PLAN

### NO-COST/LOWER COST- CONTAINMENT PROGRAMS

**Best Doctors (\$0 out-of-pocket cost)** - To question the need for surgery, need help deciding between multiple treatments, don't understand a diagnosis or treatment recommendation, no diagnosis or skeptical of their physician and/or symptoms not improving.

For specified elective surgical procedures **Eligible Expenses will be paid at 100%** if a Best Doctors "Inter-Consultation" is completed **before** one of the following procedures is performed: back, hysterectomy, knee and hip replacement, obesity or bariatric, coronary artery by-pass graft, heart valve replacements, prostatectomy and lumpectomy/mastectomy.

**Global One Ventures (Bundled pricing for out-patient surgery)** - By using a network out-patient surgi-center there will be **\$0 out-of-pocket cost** for the procedure. Further, there may also be a **savings payment of \$250 or \$500** to the participant for having their procedure performed at a participating out-patient surgery facility. Contact the Trust Office for details (x-702).

**Heal "in-home" physician visits** - To avoid long waits to schedule a physician office visit or many hours waiting at an urgent care/emergency room - **Only a \$5 co-payment** for any visit routinely provided within 2 hours of making an appointment by phone or via smart phone. Hours are from 8:00 am - 8:00 pm Monday - Sunday and this program is recognized as a network provider in the Anthem Blue Cross PPO.

**Pinnacle medical/dental services in Mexico - \$0 out-of-pocket cost** for eligible medical and dental services rendered by only Pinnacle network providers in Mexico. A pinnacle ID card is required.

**Members' Assistance Program ("MAP") - \$0 out-of-pocket cost** for up to 8 visits within a 12 month period to address any issue or problem a participant may have.

## NOTICE OF OPPORTUNITY

### Apprentice Opportunity for the Intelligent Transportation Systems Program

The Joint Apprenticeship & Training Committee offers a complete 4-year program incorporating on-the-job training and supplemental classroom related instruction for the Intelligent Transportation Systems Program, and continues to accept applications from eligible applicants in accordance with its approved standards and selection procedure.

### How to Apply

Applications will be accepted at the San Diego Training Center Wednesdays from 2p-4p. Applicants who complete the application and provide the required documentation listed below will be invited to take an aptitude test and, with a qualifying score, interview for an opportunity to be accepted into the ITS apprenticeship.

### Required Documents

1. **Valid driver's license**  
(All applicants must be minimum of 18 years of age at the time of selection/registration)
2. **Sealed high school transcript or GED equivalency**

3. **Show evidence of successful completion of: one full credit of high school algebra with a passing grade, or one post-high school algebra course with a passing grade, or completion of the NJATC math course**
4. **DD-214 to verify military training if applicant is a veteran**

Upon completing the written exam with a passing grade of 4 or above, the applicant will be scheduled for an Oral Interview with the ITS Joint Apprenticeship Committee. The purpose of this interview is to evaluate and determine eligibility, and the proper period of apprenticeship for which the applicant qualifies. All applicants who complete the interview process will be eligible for this program subject to the needs of the industry.

#### Veterans may have testing requirement waived with all of the following:

1. **Honorable Discharge**
2. **Separated within 5 years of applying for apprenticeship program**
3. **DD214 Form (Member-4)**

**All applications will be received and processed without regard to race, color, religion, age, national origin, or sex.**
