## SUMMARY ANNUAL REPORT FOR SAN DIEGO ELECTRICAL HEALTH & WELFARE TRUST

This is a summary of the Annual Report of the San Diego Electrical Health & Welfare Trust, Employer Identification Number 95-6035916, for the period ending September 30, 2002. The Annual Report has been filed with the Internal Revenue Service as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Trust provides to all eligible participants medical, dental and vision coverages either on a self-funded basis or in accordance with the terms of the contracts for pre-paid medical, mental health and dental alternatives. A total of 2,347 persons were participants in or beneficiaries of the Plan at the end of the Plan Year, although not all of these persons had yet earned the right to receive benefits.

The Trust has a contract with Transamerica Assurance Company to pay all life and accidental death & dismemberment claims on behalf of eligible employees incurred under the terms of the contract and Plan Document. The total premiums paid for the period ending September 30, 2002 were \$216,761. The total of claims paid for the similar period was \$60,000.

The value of the Trust assets, after subtracting liabilities, was \$9,489,686 as of September 30, 2002, compared to \$13,428,617 as of September 30, 2001. During the Plan Year the Trust experienced a decrease in its net assets of \$3,840,375. The basic reason for the substantial reduction in assets during the Plan Year is that claim/premium payments increased by \$3,675,014, predominantly due to an extraordinarily high number of extremely large claims. This increase includes unrealized appreciation or depreciation in the value of Trust assets; that is, the difference between the value of Trust assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Trust had total income of \$9,640,505; including employer contributions of \$8,697,685; Employee/Retiree contributions of \$495,074; earnings from investments of \$427,639; and \$20,107 in other income.

Trust expenses were \$13,598,361. These expenses included \$12,336,950 in benefits paid to participants/beneficiaries, premium payments and reserves for future claims; \$460,687 in Trust Office operating expenses; \$781,737 in professional fees and operating expenses; and \$18,987 in investment management fees and expenses.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
