SUMMARY ANNUAL REPORT FOR SAN DIEGO ELECTRICAL HEALTH & WELFARE TRUST

This is a summary of the Annual Report of the San Diego Electrical Health & Welfare Trust, Employer Identification Number 95-6035916, for the period ending September 30, 2005. The Annual Report has been filed with the Internal Revenue Service as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Trust provides to all eligible participants medical, dental and vision coverages either on a self-funded basis or in accordance with the terms of the contracts for pre-paid medical, mental health and dental alternatives. A total of 2,109 persons were participants in or beneficiaries of the Plan at the end of the Plan Year, although not all of these persons had yet earned the right to receive benefits.

The value of the Trust assets, after subtracting liabilities, was \$9,007,490 as of September 30, 2005 compared to \$7,175,171 as of September 30, 2004. During the Plan Year the Trust experienced a increase in assets of \$1,832,319 versus a decrease of \$89,663 in the prior year. This increase includes unrealized appreciation or depreciation in the value of the Trust assets; that is, the difference between the value of Trust assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan Year, the Trust had a total income of \$20,404,410; including employer contributions of \$17,109,628; Employee/Retiree contributions of \$1,556,805; earnings from investments of \$124,743; and \$1,613,234 in other income and stop-loss insurance reimbursement receivables.

Trust expenses were \$18,572,091. These expenses included \$17,094,750 in benefits paid to or on behalf of participants/beneficiaries; premium payments and reserves for future claims; \$590,699 in Trust Office operating expenses; \$881,534 in professional fees and operating expenses; and \$5,108 in investment management fees and expenses. Trust Office expenses were much lower than last year (\$684,848) due to the absence of expenses related to complying with HIPAA legislation.

The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
