

**SUMMARY ANNUAL REPORT FOR  
SAN DIEGO ELECTRICAL PENSION TRUST**

This is a summary of the Annual Report of the San Diego Electrical Pension Trust, Employer Identification Number 95-6101801 (Plan No. 001), for the period ending September 30, 2008. The Annual Report has been filed with the Internal Revenue Service as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**BASIC FINANCIAL STATEMENT**

The value of the Trust assets, after subtracting liabilities of the Trust, was \$268,779,066 as of September 30, 2008 compared to \$313,926,930 as of September 30, 2007. During the Plan Year the Trust experienced a decrease in its net assets (after payment of all benefits and expenses) of \$45,147,864 after an increase of \$41,887,106 in the prior year.

This decrease in net assets takes into account that benefit payments exceeded employer contributions by \$6,517,919, meaning this amount must be made up through investment earnings along with funding all other liabilities. The value of the Trust's net assets includes unrealized appreciation or depreciation in the value of the Trust assets; that is, the difference between the value of Trust assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

Benefits are provided by funds managed by the Board of Trustees under the Trust. Trust expenses were \$19,669,688. These expenses included \$408,315 in operating expenses; \$1,523,627 in investment management fees and expenses; \$568,492 in Trust Office operating expenses; and \$17,169,254 in benefits paid to participants and beneficiaries. A total of 4,432 persons were participants in or beneficiaries of the Trust at the end of the Plan Year, although not all of these persons had yet earned the right to receive benefits.

During the Plan Year, the Trust had a net income of (\$25,478,176); including employer contributions of \$10,651,335; interest and dividends of \$6,225,514; net investment income of (\$42,357,168); and \$2,143 in other income.

**MINIMUM FUNDING STANDARDS**

An Actuary's statement shows that enough money was contributed to the Plan to keep it funded in accordance with the minimum funding standards of ERISA.

You have the right to receive a copy of the full Annual Report, or any part thereof on request. The items listed below are included in that report.

1. An accountant's report;
2. Assets held for investment;
3. Transactions in excess of 5% of plan assets;
4. Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates; and
5. Actuarial information regarding the funding of the plan.

The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
