Instead of going to a doctor's office or urgent care for <u>common family illnesses</u>, injuries or skin <u>conditions</u> it is possible to go to a CVS Pharmacy Minute Clinic to seek medical attention for an eye infection, earache, cold (sore throat, cough, runny nose), nasal or sinus infection, urinary tract infection, etc., as well as to treat burns, cuts, rashes, allergies and/or bug bites/stings, or to receive preventive flu shots and vaccinations. CVS Minute Clinics are accredited by the Joint Commission that accredits more than 19,000 health care organizations and programs in the United States.

CVS Minute Clinics provide convenient and affordable health care by a certified nurse practitioner or physicians assistant who have the ability to diagnose, treat and write prescriptions while collaborating with a physician medical director if necessary. If a prescription is issued it may be conveniently filled at that same location. In the event the Minute Clinic is unable to assist the person they will suggest a more appropriate level of medical care and there will be **no charge for the visit**. Presently, CVS Minute Clinics are recognized as a Blue Cross PPO provider subject to the following schedule of office visit co-payments: In San Diego County - \$10 for Sharp doctors and \$30 for all other PPO doctors; Outside of San Diego County - \$15. However, **effective October 1, 2012** the required co-payment for a visit at any CVS Minute Clinic (whether in or outside of San Diego) will be **lowered to \$10 per visit**. The balance of the charge for the Minute Clinic visit will be payable at 100% with all other allowable charges to be payable in accordance with the Schedule of Benefits for PPO providers. Most charges by a Minute Clinic for these basic services will be less than by a doctors office or urgent care facility would charge, thus your out-of-pocket share would be lower. In the event more extensive treatment is required please remember that there is a \$10 office visit copayment for all Sharp doctors and a \$30 co-payment for all other PPO doctors in San Diego County. The office visit co-payment outside of San Diego County will remain at \$15.


PENSION PLAN DEATH BENEFIT AMENDMENT

Since March 1, 2010 the only death benefit payable to the surviving spouse of a deceased participant who has accrued at least 10 vesting credits is in the form of a 100% Joint & Survivorship benefit which means the surviving spouse would receive the same benefit amount the participant would have for the remainder of their lifetime. However, if the deceased participant was under age 55 at the time of their death the surviving spouse would have to wait until the participant would have turned age 55 to commence benefit payments.

Because the surviving spouse may have to wait many years before the deceased participant would have attained age 55 the Plan has been amended to permit a surviving spouse an option to convert that eventual 100% Joint & Survivorship benefit amount into a smaller monthly amount to become payable immediately. This conversion is actuarially neutral meaning the value of the greatly reduced earlier benefit is exactly the same as the benefit amount payable when the deceased participant would have attained age 55.

The participant is then free to use this information to make a more informed decision with their physician.

HEALTH & WELFARE PLAN AMENDMENT

Presently the Rules of Eligibility for Bargaining Employees provide that if an active bargaining participant dies their remaining Reserve Account hours will be used to maintain continuous coverage for their surviving spouse and eligible dependent child(ren) until such time as they are exhausted and COBRA coverage becomes available. The Plan has now been amended to permit the same use of eligible existing Reserve Account hours upon the death of an active nonbargaining participant. To be eligible Reserve Account hours they must have been earned as a bargaining employee.

SOCIAL SECURITY RETIREMENT

here are many facets and features to collecting Social Security retirement benefits starting with whether to retire early or late, or whether to stop working entirely or to continuing to work part or full-time. Therefore, the following should be considered when thinking about retirement options:

- Can I get a projection as to Social Security benefit amounts? Yes, aside from periodic mailings by Social Security there is an online Retirement Estimator accessible at <u>www.socialsecurity.gov/estimator</u> where it is possible to change a work stop date or expected future earnings in order to generate various benefit options.
- When should I apply for Social Security benefits? It is suggested that application be made at least 3 months prior to the date benefit payments are to begin. You can apply online at <u>www.socialsecurity.gov/applyforbenefits</u> or call 800-772-1213.
- 3. How long should I plan on receiving retirement benefits? Usually for a long time as a 65- year old person will typically live to 83 while one in four 65-year olds will live to age 90 and one in ten will live to 95.
- 4. What is full retirement age? For persons born between 1943 and 1954 it is age 66. Starting with 1955, for each year through 1959 two months is added and from 1960 forward full retirement age is 67.

- 5. How much of a reduction will there be to retire early? If full retirement age is 66 then benefits will be reduced by: 25% at age 62, 20% at age 63, 13 1/2% at age 64 or 6 2/3% at 65.
- 6. How much of an increase will there be if a person retires after full retirement age? Depending on when you were born there is a monthly increase to the benefit. For people born in 1943 or later the annual increase up to age 70 is 8% and will be based upon the period of time between when you reached full retirement age and when you start receiving benefits or age 70.
